PRIVACY NOTICE

This Privacy Notice is meant to help you understand how StratCap, LLC, StratCap Investment Management, LLC, and StratCap Securities, LLC (collectively, "StratCap," "we," "us," or "our") collects, uses, and discloses your personal information ("Personal Information") in connection with the services we provide. This Privacy Notice applies wherever this Privacy Notice is provided to you and also applies to those with whom we interact with in our business-to-business relationships.

California Notice at Collection

For our California residents, we collect personal information as described under the "Personal Information We Collect" section of this Privacy Notice below. We use the Personal Information collected for our business and commercial purposes as described under the "Use of Personal Information" section below. We do not sell or share your Personal Information. We retain your Personal Information as described under the "Retention of Personal Information" section below.

Personal Information We Collect

We collect the following categories of Personal Information about you:

- Identifiers, such as name, contact information and online identifiers;
- Personal information, as defined in the California customer records law, such as name, contact information and employment information;
- Characteristics of protected classifications under California or federal law, such as age and citizenship;
- Commercial information, such as transaction information and history;

Use of Personal Information

We may use your Personal Information for a variety of business and commercial purposes. These include:

- for our vendor management purposes;

- for any other legitimate business purpose.

To the extent that we retain any Personal Information in deidentified form, we publicly commit to maintaining and using the deidentified data without attempting to reidentify the deidentified data.

Disclosures of Personal Information

We may disclose any of the above categories of Personal Information to third parties (such as our advertising networks, affiliates, our service providers and our business partners) for our operational business purposes.

We may disclose your Personal Information as part of a sale, transfer, or other business transaction, such as a corporate divestiture, merger, consolidation, acquisition, reorganization of sale or assets, or in the event of bankruptcy or dissolution.

We may also disclose your Personal Information with your consent, or for any other legitimate business purposes.

Retention of Personal Information

We retain your Personal Information for the period necessary to fulfill the purposes outlined in this Privacy Notice unless a longer retention period is required or permitted by law. Please note that in many situations we must retain all, or a portion, of your Personal Information to comply with our legal obligations, resolve disputes, enforce our agreements, and to protect against fraudulent, deceptive, or illegal activity, or for another one of our business purposes.

International Transfers of Personal Information

All Personal Information processed by us may be transferred, processed, and stored anywhere in the world, including, but not limited to, the United States or other countries, which may have data protection laws that are different from the laws where you live. We endeavor to safeguard your Personal Information consistent with the requirements of applicable laws.

Sale or Share of Personal Information

We have not "sold" or "shared" Personal Information as such terms are defined in the California Consumer Privacy Act ("CCPA"). This includes the Personal Information of individuals under sixteen years of age.

Privacy Rights

Residents in certain states, including California, may have certain rights to their Personal Information. These include:

(1) The right to access your Personal Information. You may request that we disclose to you the following information covering the 12 months preceding your request:

- The categories of Personal Information we collected about you and the categories of sources from which we collected such Personal Information;
- The specific pieces of Personal Information we collected about you;
- The business or commercial purpose for collecting Personal Information about you;

(3) The right to correct Personal Information we have collected about you.

(5) The right to opt-out of our use of your Personal Information for targeted advertising.

(6) The right to opt-out of our use of your Personal Information in connection with profiling in furtherance of decisions that produce legal or similarly significant effects (and in certain states, the right to question the reason that the profiling resulted in the decision, and if feasible, be informed of what actions might have been taken to secure a different decision).

(7) The right to limit our use and disclosure of your Sensitive Personal Information.

(8) The right to appeal our response to your request.

In some instances, we may decline to honor your request where an exception applies. Nonetheless, you have the right to be free from unlawful discrimination or retaliation for exercising any of the above privacy rights.
